## SCRATCH SINGLES KING OF THE HILL TOURNAMENT RULES

1. SCRATCH SINGLES KING OF THE HILL TOURNAMENT IS OPEN TO ALL BOWLERS (48 entries).
2. THIS IS A SCRATCH TOURNAMENT (NO handicap).
3. BOWLERS WILL BE ASSIGNED THEIR STARTING LANE.
4. EACH BOWLER WILL BOWL SIX (6) GAMES IN QUALIFYING.
5. BOWLERS WILL CHANGE LANES AFTER EACH QUALIFYING GAME.
6. THE TOP FIVE (5) TOTALS FROM QUALIFYING WILL ADVANCE TO A STEPLADDER FINAL. IF THERE IS A TIE THAT WOULD RESULT IN MORE THAN FIVE (5) QUALIFIERS, A 9TH & 10TH FRAME WILL BE BOWLED BY EACH TIED BOWLER TO BREAK THE TIE. IF A TIE RESULTS IN QUALIFYING, A 9TH & 10TH FRAME WILL BE BOWLED BY EACH TIED BOWLER TO DETERMINE STARTING POSITION.
7. PRIZE RATIO: AT LEAST 1 TO 5.
8. THE PRIZE FUND WILL BE RETURNED 100% THE DAY OF THE TOURNAMENT.
9. THIS IS AN UNSANCTIONED TOURNAMENT.
10. BOWLERS SHOULD CHECK IN AT LEAST THIRTY (30) MINUTES BEFORE SCHEDULED STARTING TIME.
